

Privacy Policy

PWV Insurance Brokers North values the importance of protecting your personal information and we subscribe to the principles as outlined in Section 51 of the Electronic Communications and Transactions Act 2002.

1. PERSONAL INFORMATION

Personal information for the purpose of this document means all information specific to you, which is provided to PWV Insurance Brokers North online. In other words, information that identifies you. PWV Insurance Brokers North will use your personal information only as appropriate in the normal course of business. The following are reasons why we would collect your personal information:

- to identify you;
- for us to process your instructions to us;
- to manage your policy/ies;
- compliance with the laws of the Republic of South Africa;
- detecting fraud; and/or
- direct marketing to you via e-mail or telephone.
